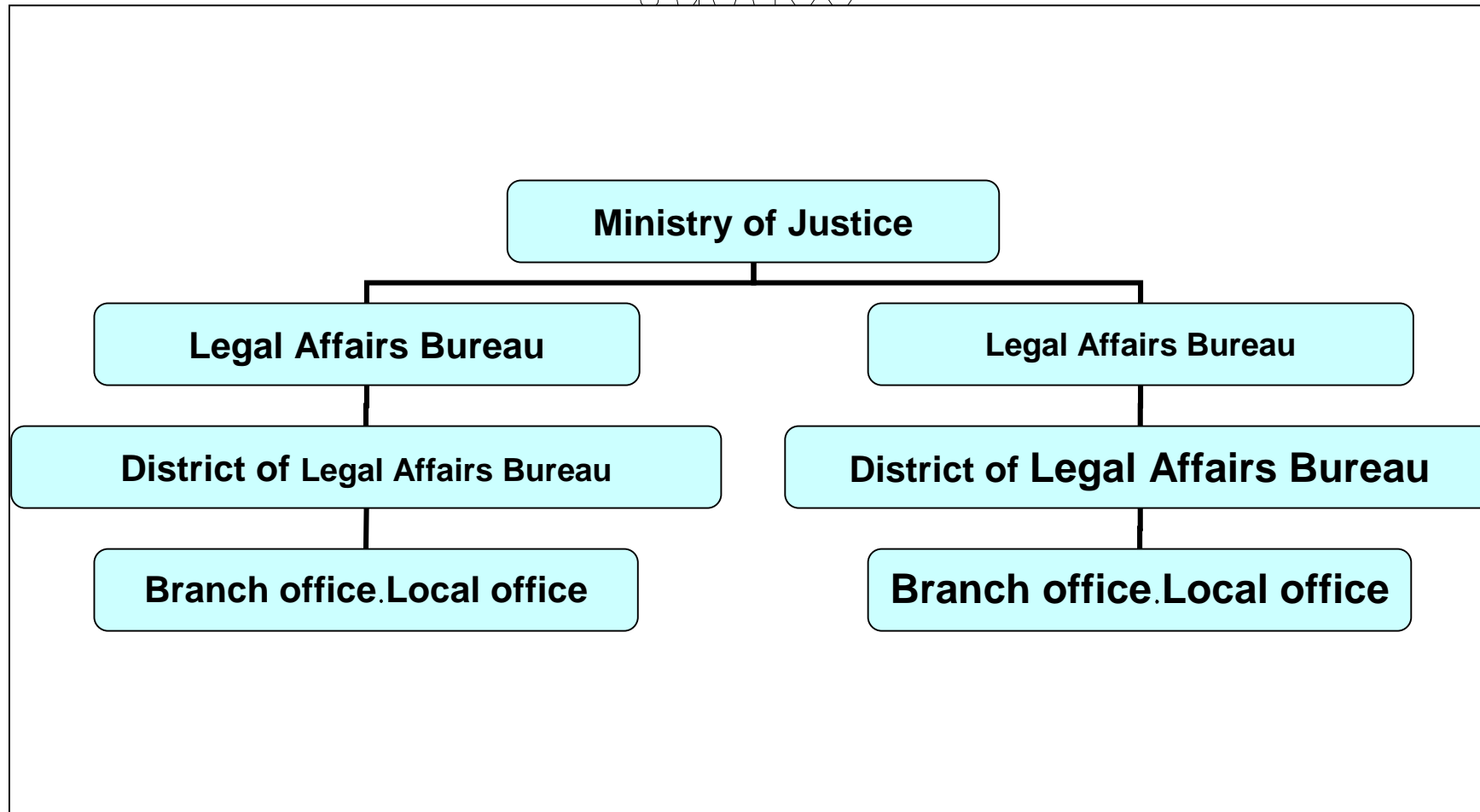

2. Transition of the Cadastral System of Japan

- **1873 Introduction of a modern cadastral system.**
 - » Tax cadastre
 - » Land ledger + cadastral map
 -A cadastral map is a drawing without restorable boundary..
- **1950 Transfer of control of land ledgers to the Legal Affairs Bureau**
 - Establishment of the land and house investigator system**
- **1960 Incorporation of land ledgers and registries (unification)**
 - » Land ledger.→.Title section...land and house investigator
 - » Registry.. → Title section ..Judicial scrivener

.3.1 Organizations of the Ministry of Justice



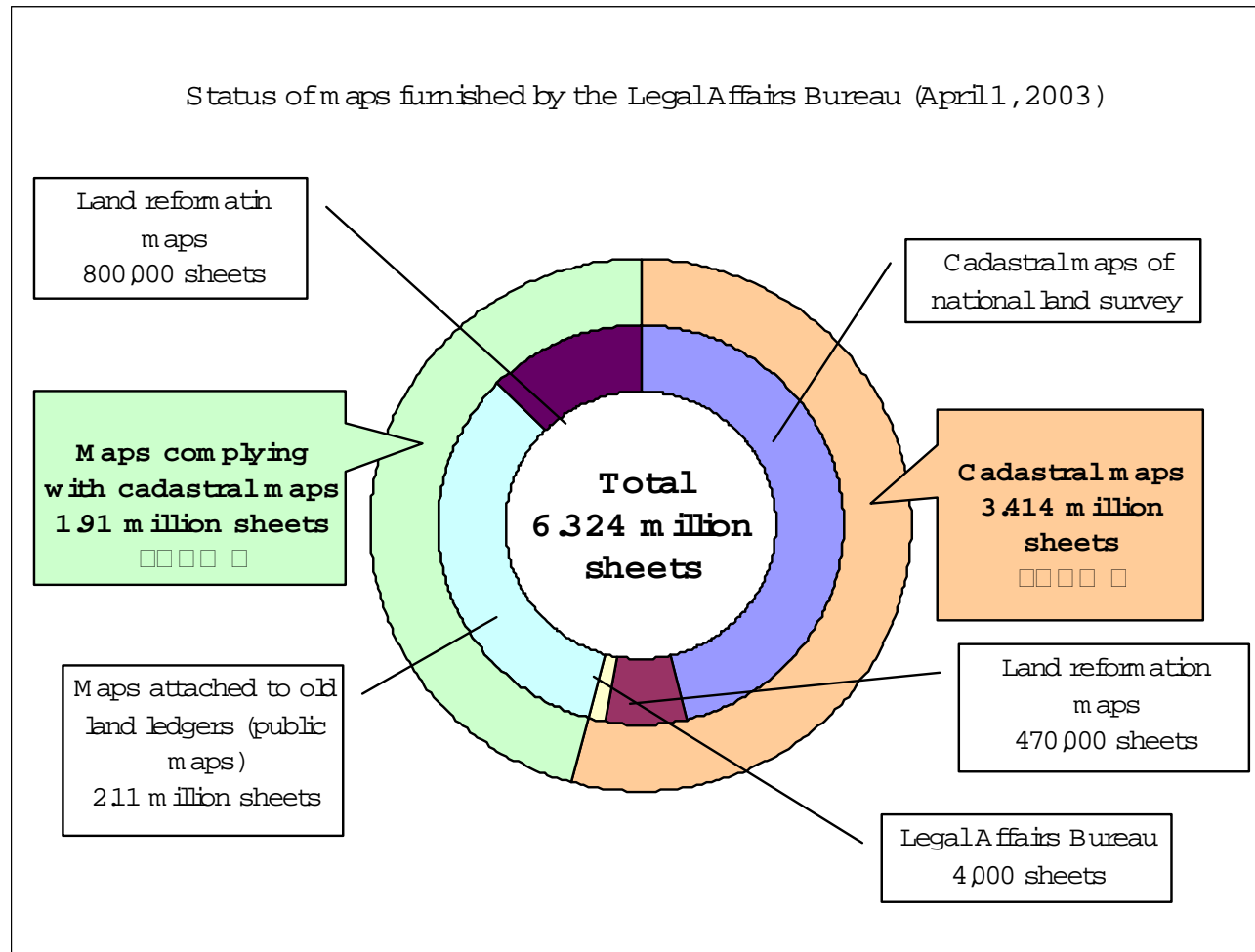
3.2 Structure of Registry

- **Registry**
 - **..Registry..Caption section.. Property identification.**
 - **..... Title section Public notification of title**
- **Drawings furnished by the Legal Affairs Bureau**
 - **..Cadastral map**
 - **..Drawing complying with the cadastral map**
 - **..Cadastral survey map**

3.4 Registration Application procedure

- Procedure defined by the Real Estate Recording Statute
- Registration application of the caption section
 - ...The applicant is obliged to confirm and survey the boundary.
- Register
 -Review of application literatures
- Proxy application..99% of applications is submitted by land and house investigators as the proxies.

3.5 Land and house investigator

- Proxy of caption section registration applications
- National license holder under the control of the Ministry of Justice
- 18600 land and house investigators
- 99% of the surveyors are engaged under privately-run offices.

3.5 Flow of the Land and House Investigator Service

- Request from a land owner
- Investigation of data and site and ongoing survey
- Analysis and examination for boundary checking
- Boundary witnessing and setting of boundary indicators
- Preparation of application forms and survey maps
- Receipt of documents after registration application and registration
- Delivery of registration documents and receipt of fees

3.6 Boundary Dispute Solution Method

- Judicial trial
- Civil arbitration in courts
- Legal boundary identification system
(Legal Affairs Bureau)
- Private sector ADR (land and house investigator)

4. Issues in the Cadastral System in Japan

.4.1. Status of unification

- **1960 Land ledger + Registry = Unification
(Unification of cadastres)**
.....
- **Preparation of cadastral maps and cadastral documents**
**National Land Survey Law, Ministry of Land,
Infrastructure, and Transport**
- **Public notification and transfer in land units**
.....**Real Estate Recording Statute, Ministry of
Justice, land and house investigator**

4.2. Maintenance Management of Cadastral Data and Control Points

- Cadastral data is not managed centrally.
 - **Boundary/survey information....land and house investigator**
 - **Registration information** **Legal Affairs Bureau**
 - **Boundary information of state-owned land...** **National and municipality offices**
 - **Cadastral survey information** **Municipality..**
- Management of control points
Not implemented practically

4.3. Boundary Verification Problems

- High Court... Boundary in terms of public law
..... Cannot be dealt with by the parties concerned
- Real Estate Recording Statute.
Verify the boundary by the parties concerned
- Problems ...Cooperation from the owner of adjacent land is not available.
.....Whereabouts of the neighbor is unavailable.
.....The adjacent land is shared by many owners.
.....Money is requested for the boundary approval.

4.4. Legal Theory of the Cadastral Survey

- Outcome of cadastral survey

.....**Not dealt with by the government**

..**No effect on boundary settlement**

- Registration change of the caption section in the output of cadastral survey
- Cadastral maps of cadastral survey are furnished by the Legal Affairs Bureau

4.5. Cadastral Education

- Caption section..Small number of researchers
 - Title section Large number of researchers
 - No faculty of cadastre/department of cadastre in universities and vocational colleges.
-↓
- Most public servants who are engaged in cadastre have not received cadastral education.

4.6.Land and House Investigators

- **Merits of the land and house investigator system**

-**Sensitive handling on the side of the owner**

-**Consultation for utilization and management**

- **Demerits**

-**No boundary settlement authorization**

-**Adverse effect of excessive competition**

-**No know-how inheritance**

-**Limitation in the system and research on the service**

-**Wasted facility investment in each office**

5. For the Future Cadastral System

- Cadastral administration by single law and single administration
- Central management of cadastral data and control points
- Enabling boundary settlement effects by cadastral survey
- Improvement of cadastral education organizations
- Incorporation of land and house investigators
- Establishment of a cadastral academic society
- Reconstruction of the cadastral system
