Accelerated Digitalisation and the Future of Land Administration - in the UN-ECE Region

Overview:

This session explores the future of land administration through the lenses of digital disruption and accelerated digital transformation – with a specific focus on lessons from the UN-ECE region.

The Covid19 pandemic showed us that not only can land administration systems survive such challenges, but they may also thrive: disruption motivated accelerated online e-service provision, rapid scaling of IT infrastructure, development of new data sharing partnerships, and the creation of new demand-driven land data products. These influenced SDG-related issues including health, emergency services, housing provision (for vulnerable groups), and agricultural production. That said, these opportunities create challenges including increased cyber-threats, social digital division, and undermining of traditional business model, amongst others.

Attendees of the session will hear from leaders across multiple land agencies, from both the UN-ECE and globally, recapping the journey of those agencies through the pandemic disruption, responses, and where they sit now. Also launched will be a new FAO/FIG/WPLA publication titled 'Digital Acceleration and the Future Land Administration in the UN-ECE region' that syntheses the lessons of at-distance webinars by FAO and WPLA on the same topic. The session will conclude with a panel session focusing on unpacking on land administration agencies have fundamentally changed post-pandemic, and what future action plans and investments are most needed in the sector.

Panel Session Questions:

- Is land administration embracing digital disruption?
- What are the essential elements for future land administration systems?
- How do we measure performance and ensure benefits are both realised and sustained?
- Are our lessons globally transferrable?
