



- Non recognised tenure that is not captured in the records impacts on rights, responsible governance of tenure, decision making from disaster






Restricted registry	Can be community based
Requires legal, surveying input	Uses simple forms
Costly proprietary software	Uses free or open source software

Pilot Project

Process should be:

- Determine what is legitimate tenure
- Determine what to record to determine legitimate tenure
- Visit occupants
- Record information
- Make information accessible

- Meeting with state institutions to discuss process
- Decide on areas to be used for pilot
- Visit areas
- Collect data
- Input in STDM software


