- ▶ **2017 Three Workshops of the Coordinating Agency for Federal Geographic Information (GCG)**
- ▶ **2018**
 - Mandate in «Aktionsplan Digital Schweiz»
 - **Mandate by Federal Council** («Eckwerte für eine Datenpolitik der Schweiz»
9th May, 2018 : Lead swisstopo, time frame: Q4-2020)
- ▶ **2020 New strategy approved** by Federal Council and Swiss Conference of Directors of Construction, Planning and Environment (BPUK)




