
Types of PLRs

- Ownership of minerals compared to land parcel ownership
- Restrictions applying to constructions on surface parcels





- Protection restrictions in the surrounding area/space
- Protection of views
- Physical environment
 - (Soil, surface and groundwater, air, landscape protection)



(Vegetation, wildlife, habitats, conservation areas)

Socio-economic environment

(Lifestyle, cultural characteristics, quality of life, health conditions)







Types of PLRs

- Restriction zones in the vicinity of airports
- Flight restrictions on manned or unmanned air vehicles





- Depth/height restrictions on exploiting surface parcels
- Building restrictions on exploiting surface parcels
- Cultivation restrictions on surface parcels
- Spatial planning restrictions
- Urban planning restrictions
- Construction regulations











- Floor Area Ratio

- > Protection of architectural characteristics (e.g. façades)















Modelling PLRs on the legal part of LADM (Kitsakis et al., 2021)



Conclusions

- Extensive research on the different fields related to PLRs
- Slow growth on individual PLR research
- Mainly the 2D aspect of PLRs is considered
- Private-Law approach is mainly followed
- Which PLRs are and need to be registered/shown on 3D?
- Several PLRs defined by qualitative parameters, not easily quantifiable
- Thematic cadastres do not always present the restriction, but the object itself
- Restrictions can be classified in multiple groups depending on classification's objective
- Selection and organisation based on national priorities of LAS
- Organisation in LADM for specific fields (e.g. Spatial Planning Package)
- Organisation of PLRs within LADM remains complex (number of PLRs, complex definitions of restrictions, different approaches on modelling and classification of PLRs)
