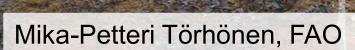

- enhance condition of rural populations.

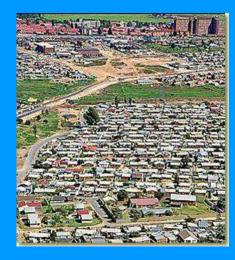


FAO is one of the largest technical agencies in the United Nations system and has 191 member nations.

Weak Governance

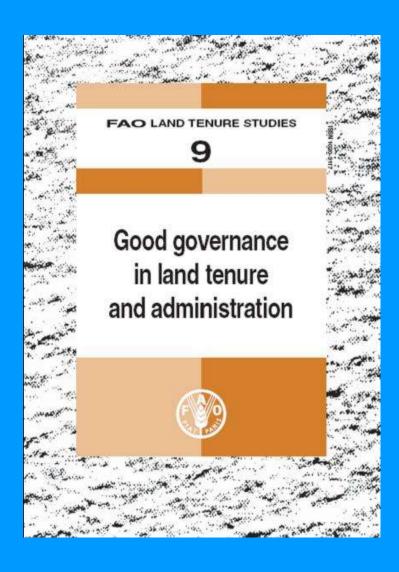
- The law is complex
- Weak judiciary
- Weak institutions
- Corruption
- Poor motivation, low pay and poor training
- Favouritism
- Vulnerable
 - Post-conflict situations





Weak Governance

- Administrative corruption
 - The abuse of office by individual officials for self-enrichment
- State capture
 - The state captured by few for their own benefit
 - Passing of laws and regulations, civil and criminal, court decisions, favourable tax and customs treatment and the corrupt mishandling of funds
 - Land administration serves the interests of those in control





FAO and Governance of Land

- Weak governance of land can undermine all development
- Affects mainly the poor vulnerable





Weak Governance

 Weak governance of tenure stagnates groups to different level of shoes!



Actual experience of paying bribes in any form with land services (buying, selling, inheriting, renting) is significant.

Perception to the payment of bribes to land authorities is to varying degrees commonplace to obtain favourable decisions.

These actual experiences and perceptions exist to a greater or lesser degree in almost all countries, and in all regions.

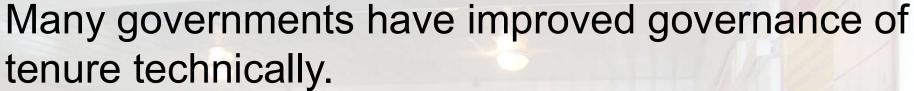


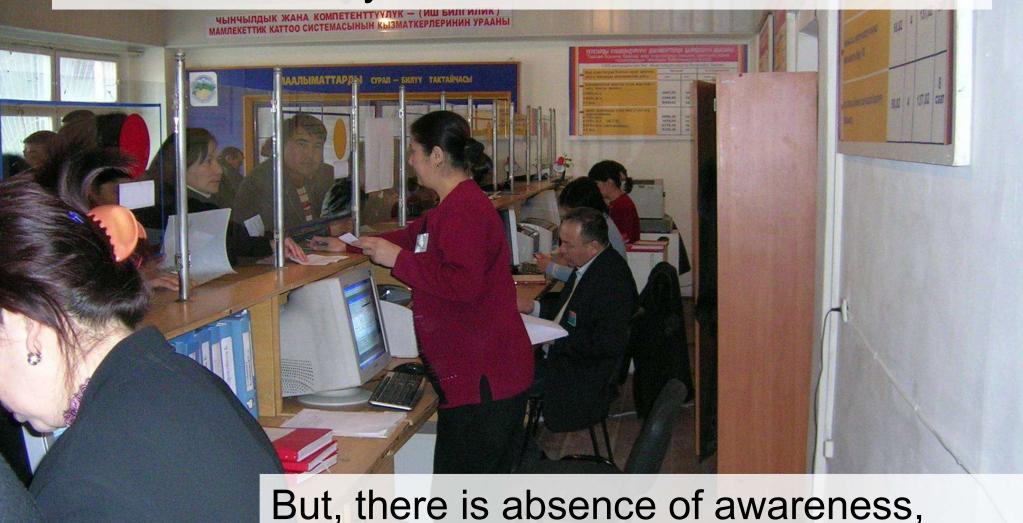
Applying Good Governance

- Property taxation, privatization and restitution
- Land use planning
- Professional services
- Management of customary land
- Development of projects.







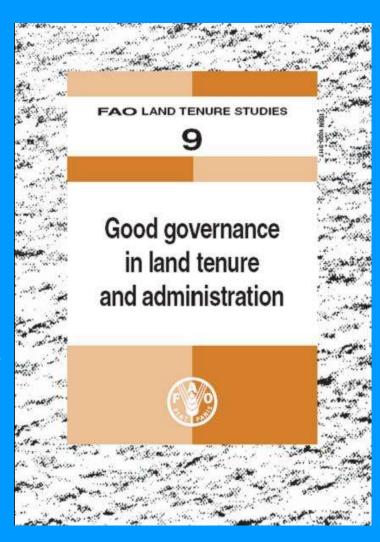


But, there is absence of awareness, policies and actions to tackle the grand scale problems.



Practical Measures

- Introduce FW for transparency
- Set service standards
- Improve systems and processes
- Build capacity
- Secure finances
- Develop a HR policy
- Establish independent auditing
- Make use of IT and communications
- Support professional organizations
- Strengthen customary institutions





Finally

- Reversing weak governance is a long-term continuing process
- Willingness!
- Opposition from people who wish to maintain the benefits
- Good governance capacity
- Good governance in land tenure and administration is not easy, but it is attainable.
